Family Planning Presumptive Eligibility (FPPE) FAQs



Program Overview

1. What is FPPE?



- Family Planning Presumptive Eligibility (FPPE) is **immediate, temporary** coverage for [Illinois' new Medicaid for family planning program](#).
- People of any age, gender, or immigration status **can apply**.
- To enroll in FPPE, patients **self-attest** to their eligibility with a registered FPPE provider.
- Even if patients do not qualify for ongoing coverage, any services rendered during the FPPE period will still be **fully covered** and coverage can be used anywhere that accepts Medicaid.

Summary**

- FPPE lasts **31-60 days**. It starts the date that someone applies and lasts through the end of the following month.
Ex: Oct 1 – Nov 30
Ex: March 15 – April 30
- Coverage is **effective immediately** after the patient completes the self-attestation, though it may not appear in Medi for 48-72 hours.
- Patients will not receive a follow up notification or insurance card. We **recommend printing a summary of their application** with their last date of coverage.

3. How can I make the most of temporary coverage?

- Connect eligible patients to ongoing 12-month HFS Family Planning Program coverage by referring them to an enrollment navigator or assistor. To be eligible for 12-month coverage, individuals must meet all of the eligibility requirements for FPPE *and* be a U.S. citizen or qualifying resident.
- Reminding patients they can enroll in FPPE up to **2x per calendar year**.
- Writing a 3-month prescription for hormonal birth control for a single pick up.

4. Who qualifies for FPPE?




You can apply as an individual if:

- You're a resident of Illinois.
- You make \$3,841 a month or less before taxes.
- You are not currently pregnant.
- And you don't already have Medicaid.

You should also know that coverage is open to:

- People of all genders.
- People of all ages.
- People with private insurance.

6. Can minors enroll in FPPE?



- Yes! FPPE and ongoing HFS FPP coverage are **both open to patients of all ages** and patients of any age can enroll and sign for their own application without a parent or guardian.
- In Illinois, **people 12+ also have the right to access birth control** and STI care on their own without a parent or guardian.

Covered Services

7. What services are covered under FPPE?



Covered services include:

- Physical Exam.
- STI testing/treatment and condoms.
- HIV testing, PEP, and PrEP.
- COVID, HPV, Hepatitis, and mpox vaccines.
- Preconception care, counseling, and labs.
- Birth control (pill, patch, ring, Depo, implant, IUD).
- Emergency contraception.
- Tubal ligation or vasectomy.
- Mammograms, pap smears/pap follow-up.
- Treatment for genital/urinary infections.

Who should enroll in FPPE?

People of any age, gender, or immigration status can apply for immediate, temporary coverage. FPPE should be offered to patients waiting to hear back on an ongoing Medicaid or HFS Family Planning Program application and those who do not qualify for other coverage because of immigration status. FPPE is not only for birth control. It can cover the cost of a visit for primary care when coupled with routine reproductive care like STI testing or screening for contraceptive needs and desires.

- FPPE applications can be done by registered FPPE providers through the ABE provider portal.
- The entire FPPE application takes about five minutes. Coverage is effective immediately for eligible patients.
- Patients do not need any proof or documentation of income, immigration, identify, employment, etc.
- All verification of eligibility is done via self-attestation (aka verbal conversation).

9. How do I verify if someone is enrolled in FPPE?

You can confirm if someone is enrolled in FPPE in Medi, just like you would for a regular Medicaid application or for the Moms and Babies Medicaid program.
